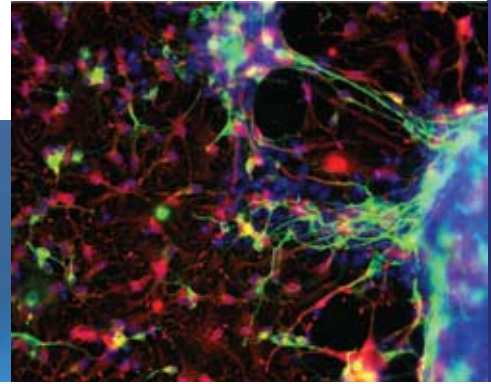

At Thursday evening's dessert reception, **Reef Karim, MD** will provide a unique perspective on the treatment of celebrities with addictions. After several days of rigorous educational activities, a BBQ dinner on Sunday overlooking Newport Beach Harbor provides an opportunity for relaxation and conversation.

As in prior years, a special track is offered for those taking the ABAM Certification Exam. The exam track has been very effective, achieving a 94% pass rate in 2008, the highest of all exam preparation courses in addiction medicine. This year we plan to improve on past years, including using an audience response system.

Pre-conference workshops on Wednesday, October 27 include: the management of pain and addictions, advanced topics in the clinical use of buprenorphine, case-based discussions of complex detoxification strategies, medical marijuana, and the role of physician well-being committees after the elimination of the California Medical Board's Diversion Program.

CREDIT

Physicians: The California Society of Addiction Medicine (CSAM) is accredited by the Institute for Medical Quality/California Medical Association to provide continuing medical education for physicians. Pain, Opioids and Treatment Across the Lifespan — What You Need to Know

Treatment of pain in patients with a history of addiction and prevention of addiction in pain patients are challenges many physicians face. This workshop will provide an overview of the differences in the presentation and treatment of pain across the lifespan. Advanced Topics in the Clinical Use of Buprenorphine

This workshop will compare buprenorphine treatment in different settings and with different populations, highlighting the effective elements. Other presentations will focus on the evidence for buprenorphine treatment during pregnancy, buprenorphine treatment for adolescents, and the management of pain in patients treated with buprenorphine. A review of the data about diversion of buprenorphine and mitigation strategies will also be covered. The concluding session will be devoted to ongoing management and treatment goals for patients stabilized on buprenorphine.

The Art of SBIRT — Motivating Patients and Teaching It Effectively

Organized by the Medical Education and Research Foundation for the Treatment of Alcoholism and Other Drug Dependencies (MERF). A limited number of scholarships is available from MERF for residents and faculty in residency training programs.

This workshop is designed for physicians who teach in residency training programs to improve teaching skills in screening for and assessing alcohol and drug use, conducting a brief intervention and making referrals to treatment (SBIRT). The majority of the time will be spent participating in interactive large group role plays and practicing clinical skills in facilitated small groups. Participants will be immersed in motivational interviewing (MI) interactions to facilitate learning and using this important tool. A medical education specialist will train participants to diagnose learners and teach more effectively.

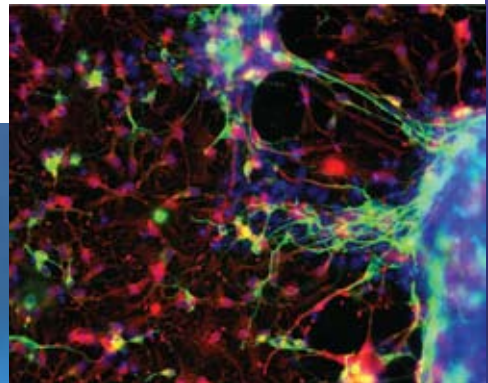
